GIFT AID DECLARATION

Marling School PTA raises money all year round to fund equipment and resources for the school. This has included funding vital school amenities such as the school minibus payments (monthly), equipment for catering, IT and PE, library books, and support for the debating society. Most recently we have funded gym equipment, a library refurbishment, tablets for internet use where pupils don't have their own, a Spray Paint Booth for Art dept., laptops for the SEN dept., Maths books, curtains for the Drama dept., and funding to maintain the current Science Enrichment program and the new GCSE practical requirements. We are currently hoping to support, in phases, new locker space for all students at the school not just year 7.

The Gift Aid scheme is a brilliant way of you donating to help fund this equipment. Under the scheme you would sign the simple declaration below which would allow the PTA to claim back the tax that would have been paid on your donation, increasing its value by the current rate of income tax. In practical terms this means that for every £3 you donate to the PTA, we can reclaim nearly £1 from the Government. Over the years this has been a tremendously valuable source of regular income for the PTA.

No donation is too small and all are valued – you can donate as little as £1 a month.
